Arizona has 10 NAWCA projects either completed or underway. These projects have conserved 6,686 acres of wildlife habitat. NAWCA funding of more than \$1.7 million stimulated partner contributions of over \$8.9 million. These figures do not include multi-state projects.

WHITEWATER DRAW WILDLIFE AREA WETLAND RESTORATION PROJECT

The Whitewater Draw Wildlife Area is in the Sonoran Joint Venture's boundaries and owned and managed by the Arizona Game and Fish Department. This project will acquire 80 acres and restore 40 acres of seasonal wetlands important to wintering migratory bird species, including mallard, pintail, sandhill crane, Swainson's hawk, doves and shorebirds.
