TOTAL ACRES

Illinois has 36 NAWCA projects either completed or underway. These projects have conserved 41,664 acres of wildlife habitat. NAWCA funding of more than \$7.8 million stimulated partner contributions of over \$30.6 million. These figures do not include multi-state projects.

HEART OF THE BIG RIVERS

This project focuses on the protection, restoration and enhancement of wetland habitats associated with the Mississippi and other major rivers of the southern Upper Mississippi River (UMR) and northern Mississippi Alluvial Valley (MAV) for the benefit of migrating and wintering waterfowl and other wetland-dependent migratory birds and wildlife.

The projects chosen for this proposal are all connected to the floodplain of the Mississippi River and its tributaries or were historically connected as such prior to human alterations of the landscape and hydrology. DU and its conservation partners propose to permanently protect 751 acres of forested, emergent and scrub-shrub wetlands in the floodplains of the Mississippi and Missouri Rivers. An additional 1,090.6 acres of converted wetlands will be restored to either re-establish and mimic historical hydrology or transition previous or current agricultural lands back to bottomland hardwoods and seasonal, emergent wetlands.

Finally, 300.1 acres of existing wetlands which have degraded due to insufficient management infrastructure, prior human disturbance, or vegetative encroachment will be enhanced. The project will benefit numerous waterfowl species, upland birds and other wetland-dependent species.
