North Carolina has 32 NAWCA projects either completed or underway. These projects have conserved 116,367 acres of wildlife habitat. NAWCA funding of more than \$21.3 million stimulated partner contributions of over \$69.3 million. These figures do not include multi-state projects.

## SOUTHEASTERN NORTH CAROLINA WETLANDS INITIATIVE Ш

This is the third phase of a continuing effort to permanently protect wetlands and associated uplands in the Cape Fear Arch Region, an area of unique natural diversity, housing species found nowhere else in the world. This region contains a variety of wetland habitats including coastal salt marsh, cypress-gum swamps, bottomland hardwoods, Carolina Bay lakes, beaver ponds and pocosin. However, it is experiencing unprecedented growth and development and the threats from wetlands loss, degradation and fragmentation increase each year.

This project will protect 3,125 acres in the region, benefiting four federally threatened and endangered species, nine federal species of concern, 17 other state listed and rare species and 40 other fish and wildlife species.
