*Indiana has 26 NAWCA projects either completed or underway. These projects have conserved 52,133 acres of wildlife habitat. NAWCA funding of more than \$12.9 million stimulated partner contributions of over \$38.3 million. These numbers do not include multistate projects*

## NORTHEAST MORAINAL WETLANDS

This proposal focuses on wetland and upland habitat protection, restoration, and enhancement in the 11 northeastern-most counties of Indiana, in an area dotted with glacial lakes and pothole wetlands. The area faces new agricultural development, the conversion of farmland to residential areas, the expansion of commercial development and the development of gas and oil resources.

The primary goals of this proposal are to provide breeding habitat for waterfowl and improve water quality in this region of northeastern Indiana. These goals will be achieved through the protection of important conservation lands, restoration or enhancement of drained and degraded wetlands and the establishment of native grasses in areas previously converted to agricultural production. The project will also stimulate local economies through recreation on project lands and offer a host of other benefits.
